ORDER

1. As per papers read (1) and (2), revised Regulations, Scheme, Syllabus and Model question papers of LLM programme under Choice Based Credit and Semester System (CBCSS) were implemented in the University Departments w.e.f 2015 and 2020 admissions respectively.
2. The existing Eligibility criteria for admission to the LLM programme w.e.f 2015 admission and 2020 admission are the same which states that "A candidates who has passed the LLB examination of Kannur University or of any other University recognized as equivalent there to and has secured not less than 50% of the marks in the aggregate shall be eligible to be considered for admission".
3. As the eligibility criteria does not specify whether candidates who passed 3 year LLB, 5 year LLB, 5 year integrated LLB (such as BA -LLB, BBA-LLB B.Com LLB etc, are eligible for admission to LLM programme, the Examination Branch of the University withheld the result of such candidates.
4. Subsequently, the Head, School of Legal Studies, Dr.Janaki Ammal Campus, Palayad, Thalassery, as per paper read(3) above requested to modify the Eligibility criteria incorporating various integrated LLB Degrees also, to overcome the uncertainty of future of such candidates, who are already admitted to the LLM programme.
5. The matter was considered by the Board of Studies in Law(Cd) in its meeting held on 29.11.2021 and the meeting recommended to substitute the existing clause 3.1- Eligibility in the Regulations of the LLM programme w.e.f 2015 and 2020 admission, as detailed below.
"A candidates who have passed the LLB examination of Kannur University or of any other University recognized as equivalent there to, (including 3 year LLB, 5 year LLB, 5 year BA-LLB BA -LLB, B Com -LLB, BSc -LLB, BBA-LLB or any of the integrated 5 year LLB course designed by the Bar Council of India) and secured not less than 50% of the marks in the aggregate shall be eligible to be considered for admission". The substitution shall apply retrospectively from the date of approval of the respective original Regulations."
6. The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11(1), Chapter III of Kannur University Act 1996, accorded sanction to fix the Eligibility Criteria for admission to the LLM programme (CBCSS) w.e.f 2015 admission and 2020 admission, as detailed in para (5) above.
7. The modified Eligibility Criteria for admission to the LLM programme(CBCSS) w.e.f 2015 and

2020 admissions are uploaded in the University website (www.kannuruniversity.ac.in).

8. The U.O read (1) and (2) stands modified to this extent.
