ORDER

1. All the full time/part time research scholars registered under pre-revised and revised regulations shall submit his/her PhD final thesis after a minimum period of three years and within a maximum of 5 years for full-time and 6 years for part time scholars, from the date of registration.
2. One year extension through re-registration may be granted to both full time and part time scholars by the Vice chancellor by paying a fee of Rs. 2,500/- and Rs. 5,000/- who were registered as per pre-revised regulations and revised regulations respectively.
3. In the case of research scholars who were granted PhD registration as per pre-revised regulations, the maximum condonable time period will be limited to one year by remitting a fee of Rs. 5,000/- and in the case of research scholars who were granted PhD registration as per revised regulations, the maximum condonable period for the submission of final thesis after availing the one year extension granted as per clause 6.1.1 of the revised regulation, is limited to one year by remitting a fine of Rs. 25,000/- as per the paper read (1) above.
4. As per the reference read as (2) above, a committee comprising the Convenor of Course, Research, Library and Publication Dr. Wilson V A, Dr. P J Jacob, Dr. P Omana, and Dr. T P Ashraf was constituted to propose the penalty amount to be imposed on the research scholars against the delay in the submission of the PhD final thesis after availing all eligible time periods.
5. The committee in its meeting held on 15-12-2016 made the following recommendations.
 - Research scholars who were granted registration as per pre revised regulation and did not submit the PhD final thesis after availing all the eligible time periods, will be granted a grace period of six months for the submission of the final thesis by remitting a fine of Rs. 10,000/-. Further an extension of six months will be granted as mercy period on request by remitting a fine of Rs. 15,000/- and recommended to place the matter before the Syndicate.
6. The Syndicate in its meeting held on 17-01-2017 approved the recommendations vide the paper read (4) above.
7. The following orders are therefore, issued in the matter as approved by the Vice-Chancellor by implementing the Syndicate resolution.

i. The fee for extension of time through re registration by the Vice Chancellor, for the submission of the Final thesis in respect of the candidates who have registered as per pre revised regulation is Rs. 2,500/- and as per revised regulation is Rs. 5,000/-

ii. In the case of research scholars who were granted PhD registration as per pre-revised regulations, the maximum condonable time period will be limited to one year by remitting a fee of Rs. 5,000/- and in the case of research scholars who were granted PhD registration as per revised regulations, the maximum condonable period for the submission of final thesis after availing the one year extension granted as per clause 6.1.1 of the revised regulation, is limited to one year by remitting a fine of Rs. 25,000/- and on the recommendations of the Syndicate.

iii. Research scholars who were granted registration as per pre revised regulation and did not submit the PhD final thesis after availing all the eligible time periods, will be granted a grace period of six months for the submission of the final thesis by remitting a fine of Rs. 10,000/-. Further an extension of six months will be granted as mercy period on request by remitting a fine of Rs. 15,000/-

8. Orders are issued accordingly.
