PG Programmes in Affiliated colleges w.e.f 2023 admission - The syllabi of which are not revised in tune with PG CBCSS (OBE) Regulation 2023 - Uniform Procedure for valuation adopted ( Double Valuation) for all PG Programmes in affiliated colleges-Approved -Orders issued.

## **ORDER**

- The revised Regulations for PG programmes in Affiliated Colleges was implemented w.e.f 2023 admission vide paper read (1) above, and as per read (2), the Clause 7.14 of the Regulation were modified in view of the decision of XXVI th Academic Council and reinstated double valuation in PG Examinations and stopped revaluation.
- 2. However, the syllabi of 8 Programmes viz, M A Governance & Politics, M A Social Science with specialisation in History, M.Sc Plant Science with Bioinformatics, M. Sc Statistics with Data Analytics, M A Decentralisation & Local Governance, M A Public Policy & Development, M A Social Entrepreneurship & Development, and M C A, were not revised in tune with this Regulation and the regulation applicable to these 8 Programmes were 2014 PG regulation which retain the provision of revaluation.
- 3. Hence the Examination branch, vide paper read (3) pointed out the practical difficulty to follow two system (double valuation and revaluation) simultaneously for PG programmes in Affiliated colleges and also sought clarification whether double valuation of answer scripts may be made applicable to these 8 programmes, which were not revised as per 2023 PG CBCSS(OBE) Regulation.
- 4. The Vice Chancellor, after considering the matter in detail, and in exercise of the powers of the Academic Council conferred under Section 11(I) Chapter III of Kannur University Act 1996, accorded sanction to adopt uniform procedure for valuation of answer scripts in respect of all PG Programmes in Affiliated colleges. Therefore, Double valuation of answer scripts, without the facility of revaluation is made applicable for all PG programmes in Affiliated colleges w.e.f 2023 admission, subject to report to the Academic Council. Already published results need not be re-opened and remain so.
