**ORDER**

1.The Sub-clause (ii) of clause 5 "Pass requirements" in the the existing Regulations for Post Graduate programmes under the School of Distance Education vide paper read (1) has been amended vide paper read (2) as " *In the case of failed candidates having not less than 40% aggregate marks for all papers of the concerned year, they shall be permitted for paper wise reappearance of paper/papers in which they have not secured 30% marks. In such case, for a pass the candidate should obtain 40% marks in paper/ papers in subsequent appearances. In the case of candidates who do not have an aggregate of 40% marks in a particular year, he/she need to re appear for the paper / papers in which he/she has not secured 40% marks*", w.e.f from 2015 admission onwards.

2.Considering the request of PG students under School of Distance Education, *the benefit of availing the provision of writing only the failed papers instead of all papers, was extended to all students of 2014 admission for Post Graduate courses offered under School of Distance Education, vide paper read (3) above, as that of the permission granted for 2015 admission students, with the following conditions.*

- i).Passed out candidates shall not be considered for the benefit.*
- ii)Marks obtained by the candidates in the last attempt of the examination shall be taken as the criteria for pass.*

4.Meanwhile, vide paper read (4) above, a candidate of PG programme (SDE) requested to extend the benefit vide paper read (3), to candidates of PG (SDE ) students of 2013 admission also.

5.As per paper read (5) above, the meeting of the Syndicate held on 15.09.2020, resolved vide the Resolution No.2020.384, to extend the benefit of writing failed papers only, instead of all papers, to the PG students of 2013 and earlier admission under School of Distance Education of the University.

6.The Vice-Chancellor, after considering the whole matter in detail and in exercise of the powers of the Academic Council conferred under section 11 (I) Chapter III of Kannur University Act.1996 and all other enabling provisions read together with, has accorded sanction to extend the benefit of writing only failed papers instead of all papers to 2013 and earlier admission students of PG (SDE) as that of the permission granted for 2014 admission students, with the following conditions.

i)Passed out candidates shall not be considered for the benefit.

ii)Marks obtained by the candidates in the last attempt of the examination shall be taken as the criteria for pass.

7.The U.O read (3) stands modified to this extent.

Orders are therefore, issued accordingly.
