ORDER

1. The Regulations for Ph.D Registration and award of the Degree of Doctor of Philosophy 2011 was implemented in this University w e f 01-01-2011, in compliance with the UGC Regulations on minimum Standards and Procedure for the Award of Ph.D Degree Regulation 09.

2. As per regulations, cited first above, coursework was made mandatory to all Ph.D Programmes and the candidates registered for coursework leading to PhD programme shall undergo a coursework of six months/one semester duration and appear for the Preliminary Qualifying Examination within one year of getting registration. The Preliminary Qualifying Examination Consists of two theory papers, Dissertation and Viva-voce.

3. The coursework was started on 21-12-2013 at each coursework centres identified for the particular subject. The time limit for the submission of Preliminary Dissertation expired by 20-12-2014.

4. Vide the reference read (2) above, an extension of time upto 31 March 2015 was granted to all the scholars for the submission of the Preliminary Dissertation without imposing any fine.

5. As per the reference read (3) above some scholars have further requested to extend the time for the submission of the Preliminary Dissertation due to various reasons.

6. As per the reference (4) above, the matter was placed before the Standing Committee of the Syndicate on CRLP and the committee resolved to extend the time limit for submitting the Preliminary Dissertation upto 31-05-2015 to all the candidates who have completed coursework during 2013-14, by remitting a fine of Rs. 1,500/-.

7. The following order is therefore issued on the matter as approved by the Vice Chancellor.

The time limit for the submission of Ph.D Preliminary Dissertation is extended upto 31-05-2015 to all the candidates who have completed coursework during 2013-14, by remitting a fine of Rs. 1,500/- .
